Through the pursuance and referenced of advocacy meeting in PY4 conducted by NSDO on September 6, 2017 based in Kunduz Deputy Governor Office that participants of advocacy meeting were Kunduz Governor's Deputy, Kunduz Mayor, Head of education department, head of Kunduz Public Health, Deputy of BRESHNA's Directorate, NSDO's Executive Director, Civic Educators, NSDO advocacy group members, Head of CDCs and ACEP consultant. The participants of this advocacy meeting raised their questions surrounding the unresolved problems accumulated through the previous community dialogue sessions at the Kunduz Center. The questions raised consisted of the "Increasing of addicted persons, increasing of beggar kids, Bothering people in the park, Increasing of electricity price and Low implementation of job descriptions in Kunduz Traffic, Lack of schools, old electricity lines, lack of clinics, lack of drinking water, Asphalting the main road of Rustaq Abad, Lack of drinking of plumbing water in Sar-e-dawra village, Lack of concretes rills in Sar-e-dawra village, Gravelling the roads in Sadarak village, Lack of recycle bins in Sadarak village and displaced people in Charmgery village of Kunduz province".

At the result of conducting the advocacy meeting with Kunduz Deputy Governor in PY4 – among the problems which were addressed in above by the community people – one of the problem which was not giving service and activating clinic of Sar-e-dawra village of Kunduz center for the people. Fortunately NSDO achieved its objective in terms of solving the problem through several follow – up meetings with Kunduz Public Health Department resulted to be reopened the clinic and provides health services for the people of Sar-e-Dawra village of Kunduz center.

The BHC is opened at 08:00AM and closed 04:00PM right now and intends to operate 24 hrs in the future. Average of 70 – 90 patients are being treated and cured by the deployment staff of Kunduz Health Department and following sections are active in this clinic; Nutrition advisory section, Midwifery section, Vaccination section and assigned doctor for providing health services on daily.
